Permanent or temporary Customs clearance through EORI ** (including 1 HS Code)	€ 310.00 / customs bill
Issuance or closing of customs transit document (T-1)	€ 250,00 / doc.
Bond fee (temporary import only)	3% of CIF value (€ 145.00 minimum)
Export Customs Clearance with EORI	€ 195,00 / customs bill
Customs inspection	As per receipt +10% outlay fee
Duties / taxes / VAT	As per customs bill
Advance fee (use of DSV Deferment) for payment of Customs duties & taxes (permanent import shipments only)	15% on duties/taxes amount (€ 100.00 minimum)
Additional HS Code for permanent entry (after 1 included)	€ 15,00 / Each HS code
Any involvement of additional Agencies	As per receipt

* Please note, ATA goods can not be packed together with other cargo under different type of clearance.

* Any additional costs incurred to courier documents, such as ATA carnets, will be charged accordingly.

** Permanent importation can be performed only if the customs bill can be consigned to an Italian company (that has to allow us to proceed) Or foreign company with valid EORI number.



Airfreight Shipment (from MXP to FOT Showsite or back)

From free arrival MXP to DSV Advanced warehouse Not unloaded incl.transfer, airport handling (ratio 1:333)	€ 3.00 per kg / exhibitor (min 150kgs)
From DSV Advanced warehouse to exhibition stand	pls check site handling tariffs section

* if cargo exceed 2000 kg chargeable pls apply to our office to agree ad hoc rate

- Ratio 1m3 = 333kg
- Airport storage / airline charges will be charged as per outlay + 10% outlay fee
- Xray examination or magnetism inspection if any as per outlay + 10% outlay fee
- Delivery/pick up on weekend (SAT/SUN) or during national Holiday TBA
- Waiting time at showsite (if any) as per receipt +10%
